

## The ARTRIM Finger Joint Edge Glue Board Limited Warranty

This limited warranty is based solely on the terms and conditions set forth herein, and the remedies stated herein are the exclusive remedies in the unlikely event of a product failure. Failure to store, install, paint and maintain the PFJ Board in accordance with the Handling and Maintenance Guide and the conditions contained therein will void the limited warranty.

### Primer 5 Year Limited Warranty

If any PFJ Board experiences primer failure that causes material damage to its structural integrity and function, and provided that the product has been properly stored, installed, finished and maintained according to ARTRIM's written instructions as contained in the Handling and Maintenance Guide and herein, ARTRIM will provide replacement product without charge. This limited warranty is valid for 5 years after purchase date and does not cover labor, handling, installation, or other costs.

### Finger Joint and Edge Glue 10 Year Limited Warranty

If any PFJ Board experiences finger joint and/or edge glue failure that causes material damage to its structural integrity, and provided that the product has been properly stored, installed, finished and maintained according to ARTRIM's written instructions as contained in the Handling and Maintenance Guide and herein, ARTRIM will provide replacement product without charge. This limited warranty is valid for 10 years after purchase date and does not cover labor, handling, installation, or other costs.

### Exclusive Remedy

The 5 Year Limited Warranty on the Primer, and the 10 Year Warranty on Finger Joint and Edge Glue set forth above are the sole and exclusive remedy for product defect, breach of warranty and/or any other claim or damage relating to ARTRIM's PFJ Board. No other monetary, consequential, indirect, special, incidental, or other damages (including lost profits) of any kind are recoverable. Under no circumstances will ARTRIM's liability for a product defect or warranty claim hereunder (including the costs of materials, labor, damages, personal injury, and/or attorney's fee and lawsuits) exceed the original purchase price of the PFJ Board.

Other than express limited warranties given herein, there are no other warranties, including any implied warranties of merchantability or fitness for a particular purpose and hereby excluded and disclaimed. No representative or employee of ARTRIM or anyone else is authorized to make any different statement or warranty other than as set forth in this document, and any statement to the contrary is void.

### Notice and Claims Process

A Condition of this warranty requires written notice as soon as practical but in all cases within thirty days of the discovery of an alleged product defect or warranty claim. ARTRIM reserves the right to inspect the alleged defect, condition and product prior to repair or removal. Failure to provide timely notice and right to inspect before repair or removal will void this warranty.
